### Recent Notable Cases

#### Murder and Serious Violence

- R v G – Murder. Led junior for first defendant in fatal car jacking.
- R v N – Murder. Led junior in a five-handed execution-style shooting of a doorman.
- R v T – Murder. Led junior in re-trial in case where there was no body and complex legal issues.
- R v M – Murder. Led junior, stabbing of neighbour.
- R v H – Attempted murder. Leading Junior. Large scale violence in Leicester City Centre, 23 defendants.
- R v W – Preventing the lawful and decent burial of a body. Highly unusual case where defendant’s father died and was left to decompose in a small bedroom.

#### Drugs and Organised Crime

- R v R – Firearms factory. Only defendant to be acquitted of all charges.
- R v H – Conspiracy to supply cocaine. 9 defendants, supply of cocaine between Derby and Chesterfield.
- R v M – Conspiracy to produce and supply industrial amounts of cannabis.

- R v S – Large scale, nationwide conspiracy to supply cocaine. 30 defendants.
- 

#### Sexual Offences

---

- R v M – 8 defendant gang rape. Defendants and complainant all aged 14/15 years old. All defendants acquitted of all charges.
  - R v I – Rape, sexual assault, false imprisonment. Client had previously been convicted of two stranger rapes, both of which went before the jury. Acquired of all charges apart from sexual assault.
  - R v J – Rape. Defendant previously served 11 years for a stranger rape. Acquired.
  - R v P – Rape. Acquired of a campaign of marital rape.
  - R v Y – young defendant charged with the rape and sexual assault of all three of his sisters over 10 years. Case complicated further by the fact that the defendant's father was serving an IPP for the rape of one of the complainants, his daughter.

#### Proceeds of Crime

---

- R v Hutchinson and Dale – Led Junior in a case where the defendant had allegedly claimed over £2 million worth of fraudulent benefit payments, hijacking over 60 different identities. The confiscation hearing was listed for ten days with the prosecution initially claiming £1.85 million from each defendant. The case was concluded when the prosecution accepted a benefit figure of £100k from each defendant.
  - R v Lau – Led Junior in a confiscation case where the Crown were claiming over £1million. Settlement was reached before the hearing for £75,000.
